- 4. Project Updates/Discussion
  - a. Gateway Planning Update

John Lanier/Curt G/Doug H

John L – board should be doing final approval in work session on Weds. Good info on Clinton work plan. Michael asked about Clinton sub section of comp plan and NMUGA. Does gateway project include that? John doesn't know answer. Doug stated that this should be separated from zoning update discussion. John agreed it should be separated. Issue is NMUGAs can have sewers. Freeland is one. Dave reminded us that we don't want to be NMUGA. Community agreement to this. Janae said that it's good to have in plan if needed in future. Curt said zoning changes are instead of NMUGA. Melanie Bacon said all commissioners are looking at is zoning code clean-up for this year.

b. Ken's Corner Project presentation

Doug deferred to others who know more about this. Curt said funding is committed for this – \$4.3 million +/-. Won't need much acquisition of right of way. Project will be done around 2026. Mayzie – Dave got us the additional funding. Also federal funding through Rick Larsen's office. See attached info on Clinton to Ken's Korner trail. Curt will bring us any info that comes through RTPO. Rural mobility grant went to bid and was way too high (discussed last month). Doug mentioned inflation means that there's question if this will be enough money in four years. Curt said there are always supplemental funds if it comes down to last minute without enough funding.

- c. Planning for Bayview's Future- -Goosefoot Michael C/Jill Engstrom Michael said Goosefoot has changed their housing focus because no property owners in Bayview willing to step up for this. Group working on creating housing org hasn't met yet so no new info on that. More to come in future. Curt asked about 40 unit project that had been discussed. Currently paused.
- d. Clinton Progressive Association Board Dave Hoogerwerf
  Hall is having changes, which we've seen through new rental plan. Dave discussed that we don't do fundraising to pay for hall usage and he's concerned that Hall board isn't doing fundraising for local non-profit rentals. Now Hall wants to withdraw from Council. He is very unhappy about that and wants council feedback. He plans to tell Sue when he meets with her that he thinks that someone should represent Hall on Council. Carol discussed her time as president and how CPA is important part of community. Michael said that Hall used to charge everyone except Council because we have no fund raising ability. Curt asked Don Simmons to voice opinion on Hall's purpose. Don said hall belongs to community and is not a private club house. Council is in agreement that Hall needs to be active part of community and remain part of Council.
- e. Dan Porter Park Cleanup update

  Easter egg hunt coming up. Park needs clean-up. There are homeless folks living in park in various sites. She has talked to Whidbey homeless coalition, parks dept and others.

  Concern of safety of kids using park. Jan from Parks said they'd pick up anything we clean up in park but didn't commit to helping with clean up. Lots of downed branches.

  She needs to know if Council is ready to do a clean-up and can we schedule toward end of March. We may have to limit area where kids can hunt eggs because of homeless folks. Spring break week of April 4 probably. March 26 tentative date. Christina will send out email to get this confirmed. Dave asked Melanie what County's position is on homeless folks in park. State's property so County can't do anything. Very difficult problem to deal with all over county.
