e. Chamber of Commerce

Had first business meeting. 25 folks showed up – great meeting. Prepping for Easter egg hunt. EDC is giving chamber \$15,000 grant. Rain Cap Boot Camp - Number of classes being offered for businesses to get grants through EDC. Chamber looking at beautification, website, etc with their grant. Creating some walkability maps. Discussion of advocating to state reps for safety improvements and other issues that are in state purview.

f. South Whidbey School District

Joe Greenheron

Joe Greenheron is in Olympia today, working with lawmakers from our legislative district to improve funding for public education statewide.

Since our last meeting, the district reviewed mid-year testing scores, which show improvements in Math and Reading across all grade levels, for the first time since the pandemic. This helps us understand which educational approaches are currently working, and how we can improve student outcomes even more in the future.

The South Whidbey School Board voted last Wednesday to put a Bond measure to the voters. The bond is \$80 million and carries a 20 year term. It will increase property taxes by \$0.07 per \$1,000 of assessed value, or about \$37/month for the average home in our zip code.

With the input of community members, parents, district staff, and construction professionals, the district has identified the highest priority renovation projects to protect the integrity of the facilities, improve appearance, functionality and to extend the life of our buildings for another 30 years.

Curt went down to Olympia and talked to all our lawmakers about passenger only ferry project. Emphasized that it's important to be clear and specific to lawmakers to get them on board for our projects – esp good to have projects that are shovel ready.
