Clinton Community Hall

We've installed new blinds on the windows, with better light blocking, better aesthetics, and much easier (and safer) to operate since there are now only four blinds total to deal with. We are continuing to explore and plan for options for window replacement, which will likely happen in phases over the coming years.

The Clinton Holiday Market, sponsored and managed by the Hall, will happen the first week of December (Sat 6th, Sun 7th), with 27 vendors. We worked this year to focus even more on vendors selling local crafts. As in past years, there will be light snacks available and Santa will be present for photos.

We are doing some long-range planning around how the Hall can be part of broader community efforts in emergency preparedness. Board member Steve Franks is spearheading this planning effort.

With the addition of a few new organizations in recent months, the Hall now supports 32 non-profits with heavily-discounted rental rates through our Civic Use program.
