2. Approval of July Minutes: Carol moved, 2nd: Don, passed

4. Monthly Program: District 10 State Representative Clyde Shavers reported on the last legislative session and plans for the up-coming session. Clyde is the Vice-Chair of the House Education Committee. He serves on the Healthcare Committee and the Technology, Economic Development and Veterans Committee. He also serves as Assistant Speaker Pro Tem.

He reported that last session was challenging budget and main topic was cuts. They were able to maintain the education budget, remove caps on special education and keep free school meals. K-12 education is about 45% of the state's budget. In healthcare, policies and funding were heavily affected by the actions of the federal government. They maintained funding for rural hospitals. One of Shavers' bills that passed introduces maritime industry skill classes in WA high schools.

In the upcoming session, they will have to deal with thousands of WA residents losing Medicare or Medicaid. WA has created a regional healthcare consortium with OR and CA. The community development / land use committee will be studying alternatives to septic. They must allow rural communities to deal with RAIDs and the mis-matched zoning. This is a complicated issue. The committee will be figuring out new rules for soldi waste disposal based on the completed study in Island County. A bill is slowly moving forward to protect independent

water systems. In Housing, Shavers supports a bill to incentivize long term rentals over short term.
